


## **Median Family Income**

## Family Child Care Home Closure to Provider Ratio

Summary: While overall there doesn't appear to be a strong relationship between a county's income and their proportion of family child care providers who have closed (page 2), the maps show that the north and central valley regions of the state, which have lower median incomes, also experienced a greater proportion of family child care providers closing in 2021.





As the color darkens, median income increases (left), and the proportion of licensed family child care homes (FCC) who have permanently closed increases (right).

Closure and Provider Data: CA Department of Social Services, Community Care Licensing all closures in 2021




