They also work to build and support the delivery of high-quality child care services in diverse settings throughout the state. 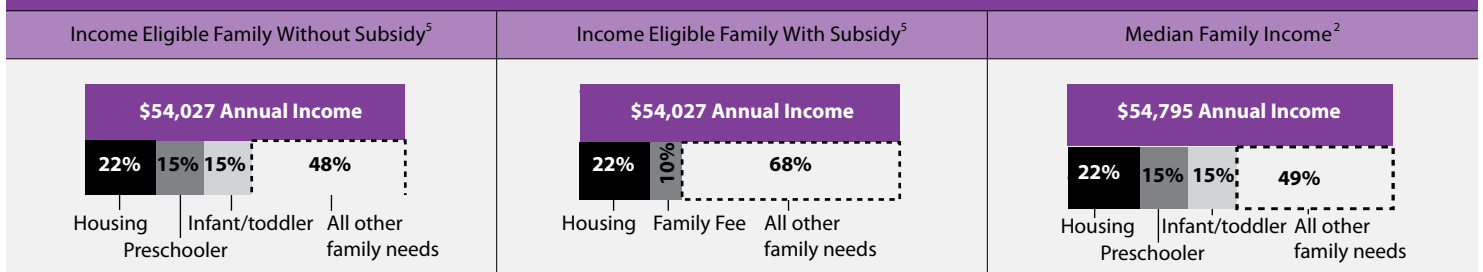
